	\$500 for an application that includes up to five Small Wireless Facilities, with an additional \$100 for each Small Wireless Facility beyond five. (My understanding is that this applies to collocation requests or requests to mount small cells to existing buildings/structures.)
<b>Recurring license fees:</b>	\$270 per year per Small Wireless Facility (this would cover any possible ROW access fee or fee for attachment to City-owned structures in the right of way.
